Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 24 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

Your Request

As per our original request (FOI ICB 24-326), please could you list which services are covered by the spend on 'CAMHS services' as per your response.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB does hold the information you have requested.

CAMHS services referred to in FOI ICB 24-326 cover includes the following:

- NHS services, including CYP mental health services commissioned or co-commissioned from or delivered in local authorities, schools, further education colleges and the voluntary sector.
- services in primary and community settings, including acute hospitals.
- any spend that is additional to that allocated in SDF funding to deliver mental health support teams in schools and colleges or as a 4-week waiting time pilot

• spend for young adults (18-25 years old) mental health can be included in full or in part in this category, or in the community mental health for adult category

It does not include:

- services for children and young people with learning disabilities and/or autism, and ADHD support or services, except where there is co-occurring primary mental health need
- new for 2021/22: investment in making specific mental health services more tailored and appropriate to young adults (18- 25s). This expenditure should be included in the relevant adult categories
- use of SDF additional funds announced for 18-25s within SDF funding.
