**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 10 December 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

We have dealt with your request in accordance with your “right to know” under section 1(1) of the Freedom of Information Act 2000 (subsequently referred to as FOIA2000) which entitles you to be provided with information “held” by a public authority unless an appropriate exemption applies.

**Your Request**

I am writing to request information under the Freedom of Information Act 2000 regarding any rebates, discounts, or other commercial arrangements that NHS North East and North Cumbria Integrated Care Board (“ICB”) has in place concerning the procurement and purchasing of testosterone gel products.

To assist with the processing of this request, I have outlined the specific information sought below:

1. Details of any existing rebate schemes, commercial agreements, or discounts that the Integrated Care Board has negotiated or is participating in concerning the procurement of testosterone gel products.
2. The terms, conditions or relevant criteria associated with the aforementioned rebate schemes, discounts or agreements.

3. The total value of any rebates, discounts or savings achieved by the ICB related to the procurement of testosterone gel products over the last three financial years.
4. Any guidelines, policies, or agreements the ICB follows when entering commercial arrangements for pharmaceutical procurement, specifically relating to testosterone gels.

## **Our Response**

On this occasion it is not possible to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested.

NHS North East and North Cumbria Integrated Care Board has no rebates, discounts, or other commercial arrangements in place concerning the procurement and purchasing of testosterone gel products.

In accordance with the Information Commissioner's directive on the disclosure of information under the Freedom of Information Act 2000 your request will form part of our disclosure log.
