Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 27 February 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Your Request


I am submitting the following questions under the Freedom of Information Act 2000. Please answer the following questions regarding this tender (notice identifier: 2023/S 000-025810):

- 1. As the host ICB, disclose the total cost incurred by the integrated care board (ICB) in running, or being part of, the non-emergency patient transport service (NEPTS) procurement exercise.
- 2. A breakdown of these costs. This should include (but is not limited to):
 - External consultancy or advisory fees, including the names of these consultancies or advisory firms; and
 - · Legal costs, including the names of the legal firms used; and
 - Any other associated expenses.

If there are any other significant costs involved that have not been described here, then please disclose them.

3. If available, the estimated cost of continuing the NEPTS contracts with the North West Ambulance Service, and the West Midlands Ambulance Service, who cover Cheshire, until the new contracts are in place from 1 April 2026.
