- 5. Is the policy in respect of the wearing of fragranced products enforced?
- 6. How is it enforced?
- 7. What training or guidance (if any) is given to staff to make them aware that use of fragranced products can be a health issue and an accessibility barrier for patients? Please provide details. If any such material is third party copyrighted, please provide a synopsis. The Trust may not have an active policy on fragrance use for staff in place while still providing guidance or training on the potential ill effects of such use for patients, so please do not disregard this guestion if you've answered 'no' to Q1.
