**Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 22 August 2024 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

Please find the information you requested on behalf of the ICB as follows.

**Your Request**

Under the Freedom of Information Act, I would like to request the following information in the template below. This information is required within 20 working days.

1. Please can the ICB confirm whether they currently commission Tier 3 weight management services?
2. If the ICB does currently commission Tier 3 weight management services, please can the ICB confirm how these are currently commissioned, e.g. as standalone service(s), or as services which are integrated within a wider service offer?
3. If the ICB does not currently commission Tier 3 weight management services please can the ICB confirm why this is the case, and clarify if they have any plans to commission Tier 3 weight management services in the future?
4. If the ICB does commission Tier 3 weight management services please can they confirm the expiry date of any current weight management contract(s), and if there are any outstanding optional extensions associated with the current contract(s)?
5. If the ICB does commission Tier 3 weight management services, please can they confirm the incumbent provider(s) of any service(s)?

6. If the ICB does commission Tier 3 weight management services, please could they provide an overview of spend on weight management services for the last 5 financial years, broken down by distinct contract(s)?
