Under the Freedom of Information Act, I would like to request the following information regarding adult learning disability services.


1. Please could you supply the name, email address and telephone number of the commissioner with responsibility for learning disabilities placements?

- 5. Please provide the number of adults with learning disabilities who transitioned from children's learning disabilities services into adult's services – into adult residential care services only, into adult supported living services only, and in total.
