<u>Freedom of Information Act 2000 – Request for Information – NHS North East and North Cumbria Integrated Care Board (NENC ICB)</u>

Thank you for your request received on 30 July 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000. The ICB covers the areas of County Durham, Newcastle Gateshead, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley.

Please find the information you requested on behalf of the ICB as follows.

Your Request

I request the following data from the NENC NHS England perinatal dashboard. For the period January 2023 – June 2025, broken down by quarters (1 Jan – 31 March, etc):

- 1. Total births.
- 2. Number and percentage of newborns with a birthweight a) <10th and b) <3rd centile.
- 3. Number and rate of antenatal SGA detection (per Saving Babies Lives Element 2 Process Indicator 2b).
- 4. Number and rate of PMRT cases with undetected FGR (per Saving Babies Lives Element 2 Process Indicator 2c).
- 5. Number and percentage of neonatal deaths.
- 6. Number and percentage of total stillbirths.
- 7. Number of percentages of term stillbirths.

Please provide this data as a whole for the NENC, and also broken down by Trust, thanks.

8. Please indicate if any of the data shared has been changed after it was initially recorded, including but not limited to the data referenced in FOI ICB 25-134 (attached): "... within the timeframes requested, one trust had a stillbirth alarm but when data completeness check was

completed, this highlighted issues with data and when this was corrected, the Trust was within 95% confidence limits." I assume this is referring to Newcastle.

Please share what the above 'data completeness check' consisted of and how the data was corrected.

- a. Was the same data completeness check and same correction applied to early comparator periods?
- b. If cases were reassigned to other Trusts based on the Trust that conducted the booking appointments, was reanalysis of other trusts' rates conducted and/or rates across this group of trusts?
- c. Was the same methodology applied to the previous comparator periods?
- 9. Please share all NENC LMNS Quality & Safety meeting minutes and reports from Jan 2023 to date.

Our Response

We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB holds some of the information you have requested.

In accordance with s.21 of the FOIA, we are not required to provide information in response to a request if it is reasonably accessible to you by other means.

2. We can confirm, as per Section 1(1) of the Freedom of Information Act 2000, the ICB on this occasion is not able to provide the requested information. In line with your rights under section 1(1)(a) of the Act to be informed whether information is held, we confirm the ICB does not hold any of the information requested. However, we have determined that the information is held by the acute hospital NHS foundation trusts (FTs) within the North East and North Cumbria region.

In accordance with our duty under s.16 of the FOIA to provide reasonable advice and assistance to an individual requesting information, we have provided the FOI email addresses for those foundation trusts to make your request.

NENC ICB is aware that there are known data quality issues with the MSDS published statistics, namely that any trust involved in a pregnancy will have a recorded booking and any trust involved in either the labour and delivery or postnatal care will have the birth record in their data, which can lead to some duplication of related activity and outcome reporting associated with multiple trusts. As a result of this duplicate recording, some births are being assigned to more than one trust in the published MSDS statistics.
