Freedom of Information Act 2000 - Request for Information - NHS North East and North **Cumbria Integrated Care Board (NENC ICB)**

Thank you for your request received by North of England Commissioning Support (NECS) on 22 January 2025 for information held by NHS North East and North Cumbria Integrated Care Board (the ICB) under the provisions of the Freedom of Information Act 2000.

The ICB covers the areas of County Durham, Gateshead, Newcastle, North Cumbria, North Tyneside, Northumberland, South Tyneside, Sunderland, and Tees Valley (which covers the five local authorities of Darlington, Hartlepool, Middlesbrough, Redcar and Cleveland and Stockton-on-Tees).

There are no specific clinical audits mentioned in the quality strategy, they are a fundamental part of the clinical effectiveness strategic theme.

The ICB has published our Clinical Conditions strategic plan, which was clinically driven and data led, it includes information about the Epilepsy audit.

The ICB has also created a clinical effectiveness subcommittee, and its purpose is to provide assurance and oversight of the delivery of effective care and treatment in the North East and North Cumbria ICS (system wide). The subcommittee will review data and intelligence, implementing continuous service improvement, making informed evidenced based decisions, and ensuring the delivery of high-quality care. The subcommittee will develop an audit plan for the year ahead, based on priorities identified through the measurement of compliance with national standards including the National Institute for Health and Care Excellence (NICE), mortality reviews and Getting it Right First Time (GIRFT).

4. Any good examples of successful cross-organisational clinical improvement (ideally involving National Clinical Audit data) to share?

The ICB does not currently hold this data across the system, there is ongoing work to develop the clinical effectiveness framework.

An internal process has been agreed at the ICB Insight Programme Delivery Group to review national audits which includes a multi-disciplinary team between personnel from key directorates reviewing audits and recommending next steps. The first 3 to be reviewed under the new process are:

- a. National Hip Fracture (NHFD)
- b. Intensive Care National Audit & Research Centre (ICNARC)
- c. National Kidney Cancer Audit (NKCA)

If so, could I have an email address of someone close to the project please. As the ICB does not currently hold this data there is currently no one delegated with the responsibility of closing this project.
