Purpose of report

Key points

4 September 2025

Finance:

• The Committee was provided with an update on the Integrated Care System (ICS) financial position for 2024/25 as of month 4, detailing potential financial risks and outlining ongoing efforts to identify additional mitigations to effectively manage the system's position.

Finance sustainability group report

 The Committee was presented with a report detailing recent activity of the group and were assured of the robust process in place to provide assurance to NHS England.

Performance deep dive: Community waiting lists

• The Committee received a presentation which contained detailed analysis of community services waiting times, highlighting data quality issues and the complexity of interpreting a national dataset

Performance update

• The Committee received the integrated delivery report which provided an ICS overview of quality and performance using data covering June and July 2025 and received the required assurance.

2 October 2025

Finance:

 Committee received an update on latest Integrated Care System (ICS) 2024/25 financial position at month 5.

Performance

 The Committee reviewed the integrated delivery report, which gave an ICS quality and performance overview with data from July and August 2025, and received the necessary assurance.

Risk register and board assurance framework

 The Committee reviewed the risk register and board assurance framework for Q1 2025/26 and received the Q4 2024/25 risk report for audit and assurance, as the May

Risks and issues

- Several potential financial risks identified within the financial plan, both for the ICB and wider ICS
- Risks largely related to the delivery of required efficiency plans which are higher than those delivered in 2024/25.
- The Committee are not compliant with the terms of reference as a requirement to meet at least 10 times a year

Assurances

- ICB finance teams will monitor and report monthly on the risks
- The financial position of both the ICB and the wider ICS will continue to be reviewed in detail on a monthly basis by the Finance, Investment and Performance Committee
- The Financial Sustainability Group will continue to review the delivery of ICB efficiencies
